New Student Application Fee	New students are required to submit a nonrefundable New Student Application Fee along with their Candidate Profile. This fee processes new student applications into our school databases.	\$130	At time of online application
Tuition Payment #1	All students are required to submit an online nonrefundable Initial Tuition Payment that will be applied to your child's annual tuition through FACTS. \$500 of this fee is applied to yearly tuition and secures the student's seat in the upcoming school year. The remainder is the FACTS processing fee, which new families were assessed in their Application Fee.	\$500 new students \$511 returning students	At time of online enrollment
Tuition Payment #2	This will be applied to your child's annual tuition and your contract will reflect this when monthly payments are calculated. Remaining selected payment plans begin billing on Aug. 1, 2026.	\$500	April 1, 2026
Activities Fee	Summit students are required to pay this fee to participate in Summit's enrichment activities (e.g.: monthly field trips, Y.A.L.E. programming, Health & Wellness activities, roller skating, theatrical programs, snow shoeing, Pod 3 Flexible Fridays, college visit learning opportunities, ski trips, fishing, community outreach, etc.). Morning Extended Daycare	Summit students are eligible to participate in Morning Extended Day (7:15 – 8:20). Drop-ins (\$20 fee) are accepted if spots are available in accordance with DHS requirements. Space is limited.	\$152/ month	Billed monthly
Afternoon Extended Daycare	Summit students are eligible to participate in Afternoon Extended Day (3:30 – 5:30). Drop-ins (\$20 fee) are accepted if spots are available in accordance with DHS requirements. Space is limited. <u>A stringent fee (\$15 per 5 minutes) will be assessed for students not picked up by 5:30 p.m.</u>	\$233/ month	Billed monthly
Morning & Afternoon Extended Daycare	Summit students are eligible to participate in Morning Extended Day (7:15 – 8:20) and Afternoon Extended Day (3:30 – 5:30). Drop-ins (\$20 fee) are accepted if spots are available in accordance with DHS requirements. Space is limited. <u>A stringent fee (\$15 per 5 minutes) will be assessed for students not picked up by 5:30 p.m.</u>	\$363/ month	Billed monthly

Please note: The final step of the enrollment process requires an Enrollment Agreement to be signed by the parents, guardians or sponsors of the student. This Enrollment Agreement applies to the entire school year, unless a student enrolls after the start date of school, in which case the Enrollment Agreement applies to the first enrolled day of school and lasts for the duration of the school year. Overhead expenses of the school, including teacher salaries, do not diminish with the departure of one or more students during the course of a school term. Therefore, tuition and all associated fees will be required to be paid in full for the entire school term ending on or about May 31, 2027. The tuition shall be due and payable even if the student is prematurely disenrolled, except under the limited exceptions noted in the Enrollment Agreement.
